



Privacy Policy

Scope

This privacy policy sets out how Coreellia AI uses and protects any personal data transferred from countries in the European Economic Area, EU, or Switzerland to the United States that are collected or received in managing our workforce and in conducting human resources and contract research activities. Coreellia AI is committed to ensuring that your privacy is protected. Should we ask you to provide certain information by which you can be identified when using this website, it will only be used in accordance with this privacy statement. The following terms may be used throughout this document and are defined here for clarification.

Personal data - means any information or set of information that identifies or can reasonably be used to identify an individual. Personal data does not include information that is encoded or anonymized or publicly available information that has not been combined with non-public personal information.

Sensitive personal data - means personal information that reveals race, ethnic origin, political opinions, religious or philosophical beliefs, or trade union membership, or that concerns health or sex life. Information will be treated as sensitive personal data when it is received from a third party that treats and identifies it as sensitive.

Privacy Principles

The following privacy principles apply to the collection, use, and disclosure of personal data by Coreellia AI in conducting human resources and contract research activities.

Website

Identifying purposes
